SESSION THREE: OVER-THE-TOP STUDY REPORT 2020 13:00 – 14:30

The new findings of a second study by the Commonwealth Telecommunications Organisation (CTO) show that many stakeholders continue to recognize and appreciate the innovative nature of over-the-top (OTT) services within the Internet value chain.
